


*Scouting Settlement Trust (“Trust”)
Instructions for Scheduling an Interview
on the Claims Processing Portal*

The purpose of this document is to provide Attorney(s) and/or Unrepresented Claimant(s) with guidance on how to locate the “Interview” tab and schedule their interview through the Claims Processing Portal. Throughout the interview scheduling process, you will receive emails from the Scouting Settlement Trust <info@scoutingsettlementtrust.com>. You can find detailed instructions below.

Interview Requested

Step 1: To continue the evaluation and determination of your and/or your Client’s Trust (“Matrix”) Claim, the Trustee may request to conduct a virtual interview with you and/or your Client (if applicable). You will receive an email from the Scouting Settlement Trust <info@scoutingsettlementtrust.com> similar to the one below.

The Scouting Settlement Trust ("Trust") has received and reviewed your Trust ("Matrix") Claims Questionnaire and any submitted supporting documents. Each Claims Questionnaire is evaluated individually, and that evaluation follows the uniform procedures and guidelines established in the Trust Distribution Procedure ("TDP").

To continue the evaluation and determination of your Matrix Claim, the Trustee is requesting a virtual interview with you. As per Article VII(A) of the TDP, this interview is being conducted under oath and as an extension of the Claims Questionnaire signed under penalty of perjury.

Interviews are time-sensitive. The Trust requires you to **schedule the interview within 45 days of your receipt of this request**. If you need to reschedule your interview, you may do so once, so long as the rescheduled interview is held and concluded within the 45-day period. If your interview is not completed within the 45-day period, your claim may be disallowed due to the Claimant's failure to submit to an interview as required by the TDP.

Prior to scheduling the interview, please take the following actions:

- (1) **File Review.** Please make sure you have reviewed your claim file. If upon review, you identify any corrections or updates that need be made (including withdrawing documents submitted by mistake and/or providing additional documentation in support of your claim), please contact the Trust and ask us to reopen the portal for you. Also, if you make any updates to the file, please notify us of the corrections or updates to your claim file before the interview is scheduled by replying directly to this email so that our interview team can review the updated claim file. In your notification email, please specify what changes you made to the file.
- (2) **Technology.** Please make sure that you have the technological capabilities to join the meeting on-camera. Also please make sure that you are prepared to do the interview in a well-lit, private location.

Once your interview date and time is confirmed, the Trust will send you a meeting invitation containing a Microsoft Teams link.

Updates from the Trust

Trust Updates:

- **Determined Matrix Claims:** The Scouting Settlement Trust reached an important milestone on January 23, 2025: More than 25% of Matrix claims have been determined – or roughly 14,500 of the 58,000 Matrix claims submitted. The Trust has disbursed \$70 million to approximately 12,300 Survivors, including Expedited Distribution Claimants, Matrix Claimants and IRO Claimants.
- **Claims Update:** We continue to make progress on all claims review and initial distribution of funds. As of February 1, 2025, the Trust had issued determinations on 21,547 claims. For additional details, please see the Monthly Trust Progress Summary [here](#).
- **Litigation Update:** The appeal from confirmation of the BSA plan of reorganization is before the Third Circuit Court of Appeals. For more information on the status of this appeal and the Trust’s lawsuit against the non-


